

DEFINITIONS & TYPES OF ABUSE

CHILD ABUSE:

Child Abuse occurs when somebody or a situation threatens the survival, security or the development of a child.

DATING VIOLENCE:

Dating Violence is violence between individuals who have or have had a significant relationship of a romantic or intimate nature.

DOMESTIC VIOLENCE:

Domestic Violence is a pattern of controlling behaviors that may include physical, sexual or emotional abuse. The violence can cause severe physical or emotional harm to adults and children.

ELDER ABUSE:

Any form of mistreatment that results in harm or loss to an older person.

TYPES OF ABUSE:

Physical: *Includes hitting, kicking, shoving, choking, stabbing, shooting, scratching, restraining or biting.*

Emotional/Mental/Verbal: *Includes making negative remarks, name calling, threatens to kill animals or to take the children or playing mind games.*

Sexual: *Any unwanted touching, forcing you to have sex or participate in any unwanted, unsafe or degrading sexual activity.*

Economic: *Preventing one from getting or keeping a job, making a person ask for money or controlling all the money.*

Social: *Spreading rumors, using religion or culture to control, using a group to embarrass or intimidate.*

MANDATORY REPORTERS:

*Anyone may report suspected child abuse, but mandatory reporters are all professionals that work with children including health-care providers, childcare or daycare providers, mental health professionals, social workers, school personnel and law enforcement. They are **REQUIRED** to do so by law.*
